◇◇ After serving more than half of his sentence, Mr. Rowshan requested a conditional release, approved by the prison officials, and he was released on 30 April 2008. Moreover, he was informed that his term of internal exile had been reduced to one year, and that he should move as soon as possible. While serving his internal exile sentence in Damghan in Semnan province, he was allowed to visit Sari after obtaining a special permit from the authorities. The remaining internal exile portion of his sentence was then changed to six months imprisonment, and he was taken back to prison to serve out this sentence.

- 34 Bahá'ís have been tried and sentenced and have completed their prison terms and/or paid their fine.
- 14 Bahá'ís have had charges cleared in their original trials or verdicts overturned on appeal.
- 5 Bahá'ís have served their prison sentences and have begun their terms of internal exile.
